The Deputy Engineer, Maharashtra Jeevan Pradhikarn, Div.2, Pune-1 has submitted proposal is for diversion of 0.1402 ha. Forest land under section-2 of the Forest (Conservation) Act, 1980 for laying underground drinking water pipeline at Karla and 07 other villages under Regional Rural Water Supply Scheme at Devghar, Karandoli, Waksai Tal. Maval, Dist.Pune in the State of Maharashtra. The details of forest land proposed for diversion is as given below: -

No tree is required to be felled for the purpose of the extent project. In this context, as per para 2.6(1) (b) & (e) of the handbook of FCA, 1980 & FCA, 2003 (Guidelines & Clarification), no compensatory afforestation is to be insisted upon.
- 2.4 **NPV:-**
  - a) The State Government shall charge the Net Present Value (NPV) for the 0.1402 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No.566 in WP (C) No.202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt.II), dated 18/09/2003 as well as letter No.5-2/2006-FC, dated 03/10/2006 and 5-3/2007-FC, dated 05/02/2009 and File No.5-3/2011-FC (Vol-I), dated 06/01/2022 in this regard.
  - b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 2.5 User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 2.6 All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (<http://parivesh.nic.in/>)
- 2.7 The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 2.8 The pipeline shall be laid down 1.5 meter below the ground and after lying down of pipe line the ground will be leveled.



- 2.9 The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 2.10 No labour camp shall be established on the forest land.
- 2.11 Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 2.12 The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 2.13 No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 2.14 The forest land shall not be used for any purpose other than that specified in the project proposal.
- 2.15 The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.
