A proposal has been received by this office from **Mohammad Saifi**, Project, Director, Plot No. 8, Toll Plaza Building, Near Sarai Toll Plaza Faridabad, for diversion (under Forest Conservation Act, 1980) of 35.16 Ha land for non-forest purpose. The subject envisages the use of Forest land for the Construction of 6 Lane access controlled Highway from DND Faridabad-Ballabhgarh Bypass Junction with Delhi-Vadodara Expressway KMP- Interchange (NH-148 NA) under Bharatmala Pariyojana (Lot-4/Pkg-1) in state of Delhi.
2. The Site Inspection of the forest land involved in the proposal has been done by me on dated 22.12.2020. During the site inspection of the site it is found that the land required by the user agency is a forest area measuring 35.16 Ha.
3. The requirement of the forest land as proposed by the user agency in Col. 2 of part I is unavoidable and is barest minimum required for this project.
