- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted necessary certificates / undertakings and Maps which are also enclosed in the proposal.
- 5.00 The proposed area comes within 10 Kms radius from the boundary of Karnala Bird Sanctuary, but the proposed site is not part of Karnala Bird Sanctuary or its ESZ. The Deputy Conservator of Forests, Alibag has certified that said Project shall not have any adverse effect on the Wildlife within the area.
- 6.00 The Deputy Conservator of Forests, Alibag has certified that no suitable alternate non forest land is available other than the forest area involved in the proposal and demand for the required forest land is lowest minimum and unavoidable.
