This project can be recommended which will benefit villages in transportation agricultural produce to the nearest market centres.</p> <p>Thus, the diversion area of <b>0.5944 Ha</b> for improvement of existing road and widening from R/F ZP road to Gerreguda with <b>width of 5.00 meters</b> over a length of <b>1188.85 meters</b>, which is falling in <b>Gudem Reserve Forest in Kaghaznagar Division</b> is <b>recommended</b> considering all the aspects mentioned in the proposal and field conditions.</p>
