A Proposal has been received by this office from M/s Indraprastha Gas Ltd New Delhi for Laying of 8" CS and 125mm MDPE gas pipe line at , Bhopa Road TP NAGAR to Jat Mujheda PWD Ch. Km. 79.400 to Km. 85.900 (Length 6.500 Km) and Jansath Flyover to Pawar Dharam kanta Village Sikheda Border along NH 709 AD Km. 97.450 to Km. 104.450(Lenth 7.00 Km.) total length Km. 13.500 in Muzaffarnagar(UP) under (FCA-1980) and Use of 0.6750 ha. of Protected forest land for non-forestry purpose. The Project envisages the use of forest land for laying under ground natural Gas Pipe line along Roads (LHS) in Village Makhyali, Jatmujeheda, Shernagar, Nirana, Tehsil- Sadar in Disst. Muzaffarnagar.

The site inspection of the land involved in the proposal has done by me on dated. 16.06.2022

On inspection of the site, it is found that the land required by the user agency is a Protected forest measuring 0.6750 ha.
