A proposal has been received by this office from State Co-Ordinating, Reliance Jeo, Infocomm Limited Dehradun, for "Construction of जनपद-देहरादून एवं जनपद-टिहरी गढ़वाल में मसूरी वन प्रभाग की कैम्पटी, भद्रीगाड़, मसूरी एवं जौनपुर रेंज अन्तर्गत एन0एच0-507 यमुनापुल-खरसौन-क्यारी माईलस्टोन-44 से माईलस्टोन-54(10.00किमी0), यमुना-मसूरी बैण्ड जीरो प्वाईन्ट (21.00किमी0), यमुनापुल-सुमनक्यारी (11.20किमी0) एवं एच0एस0 08 मसूरी चम्बा मार्ग से मसूरी-धनोल्दी- (34.00 किमी0) कुल 76.20 किमी0 सड़क /मोटर मार्ग के किनारे भूमिगत ऑटिकल्स फाईबर केबिल बिछाने हेतु" under FCA-1980 of 0.552 ha. of forest land non-forestry purpose. The Project envisages the use of, "Construction of जनपद-देहरादून एवं जनपद-टिहरी गढ़वाल में मसूरी वन प्रभाग की कैम्पटी, भद्रीगाड़, मसूरी एवं जौनपुर रेंज अन्तर्गत एन0एच0-507 यमुनापुल-खरसौन-क्यारी माईलस्टोन-44 से माईलस्टोन-54(10.00किमी0), यमुना-मसूरी बैण्ड जीरो प्वाईन्ट (21.00किमी0), यमुनापुल-सुमनक्यारी (11.20किमी0) एवं एच0एस0 08 मसूरी चम्बा मार्ग से मसूरी-धनोल्दी- (34.00 किमी0) कुल 76.20 किमी0 सड़क /मोटर मार्ग के किनारे भूमिगत ऑटिकल्स फाईबर केबिल बिछाने हेतु". The site inspection of the land involved in the proposal has done by me on dated 12-03-2020.

On inspection of the site, it is found that the land required by the user agency is a Reserve Forest + Private Forest + Civil Forest (RF 0.34 ha. + PF 0.00 ha.+CF 0.212 ha.) = 0.552 ha.

The requirement of forest land as proposed by the user agency in Col.2 part-I is unavoidable and is barest minimum required for the project.

No rare/endangered/unique species of flora and fauna is found in the area.

No protected archeological/heritage site/defense establishment or any other important monument is located in the area.

- a) The user agency has not violated the provisions of forest (Conservation), Act 1980 and no work has been started without proper sanction.
- b) AS such, recommendation is being provided.
