The Project Agency of this project is Executive Engineer, EHV, Construction Division, Kalwa. 2.00 The Project Authority has submitted a proposal for diversion of forest land 1.8947 ha. Reserved Forest, Protected forest and Private forest area for carrying out stringing work over Forest area in respect of 220 KV D/C Nagothane line from Existing Old 220 KV Nagothane (kansai) Substation to existing Old 220 KV line (Velshet), Tal Roha, Dist Raigad. Therefore the Project Authority is seeking GOI permission u/s 2 of Forest (Conservation) Act, 1980.

3.00 The forest area required for this project is 1.8947 ha. The details of land required are as under :-

4.00 The proposed area is beyond 10.00 Km of Karnala Bird Sanctuary. The project will not have any adverse effect on the wildlife within National park/sanctuary as certificated by Deputy Conservator of Forests, Alibag

5.00 The Project Authority has given undertaking to pay the cost of Net Present Value as directed by the Govt. of India. Other necessary certificates/ undertakings and maps are also enclosed in the proposal.



- 6.00 The project Authority has started the non forestry works on private forest land. There is violation of Forest (Conservation) Act 1980. Report regarding violation of Forest (Conservation) Act 1980 for the consideration of the committee constituted under chairmanship of the chief secretary vide G.R.No FLD-1089/475/part-2/F-10 dated 2/12/1991 is attached on page no 14A & 14 B.
- 7.00 This Proposal is for lying of Transmission line and therefore the Compensatory Non-Forest land is not required. Hence Compensatory Afforestation on the area of double degraded forest land i.e. 4.00 ha. is proposed. The Degraded forest land identified for Compensatory Afforestation from Reserved forest Compt. No. 653 (Gat No. 23) of village Wandroshi, Taluka Sudhagad, Dist. Raigad. The project authority is willing to bear the cost of compensatory afforestation as required by the Government and also ready to bear the cost of felling of trees.
- 8.00 The following documents are awaited from the project agency for proposal.  
The certificate under FRA (Dwellers Act), 2006 from collector, Raigad is requested by project Authority. The certificate will be attached in the proposal when it will be issued by the collector Raigad.
- 9.00 The Deputy Conservator of Forests, Alibag has carried out site inspection on dt . 30/9/2015.
- 10.00 Two Computer set with Laser Jet Printer and 1 A3 size scanner for up gradation of forest records to be provided by user agency
- 11.00 The Deputy Conservator of Forests, Alibag above report dated 6/10/2015 is self-explanatory and this office agrees with the same.
- 12.00 Four sets of proposals are enclosed herewith with all required documents for further necessary action. Proposal is submitted online vide No. **FP/MH/TRANS/15192/2015**.
