**13. Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons**

The proposal is for establishment of the Central Reserve Police Force (CRPF) 157 Battalion. The CRPF 157 Battalion, Adityapur need a plot 4.97 ha. to set up its Battalion Camping site to accommodate Administrative Building and other infrastructure like Barracks, Hospital, Quarters, Unit Canteen, Play Ground, Training Ground, Parade ground etc. Since the sub units of the CRPF Battalion are deployed in 4 different district like Ranchi, Khunti, Seraikela-Kharsawan and East Singhbhum thereby requiring a quick and hassle free movement from different place to the Headquarters. The given location will work as a nodal point for all these sub units and command, control and communication will be smooth and timely for the operational requirement of the Battalion.

The present proposal for diversion of 4.97 ha. of forest land may be considered.
