The Deputy Conservator of Forests, Dahanu has submitted the proposal mentioned in the subject vide letter No. A/20/land/685, dated 06.09.2021. Xerox copy of the same is enclosed herewith for your ready reference. The Project Agency of this project is Executive Engineer, Maharashtra State Electricity Transmission Company Limited, E.H.V. Projects Division, Kalyan.

The Project Authority has submitted in their short narrative of the proposal that this project is to transmit the power and to cater the increasing power demand at Palghar region. It is therefore proposed to construct LILO on existing 220 KV Boisar-Nallasopara Transmission Line for Palghar substation.

The scheme is approved by Maharashtra State Electricity Transmission Company Limited, Mumbai vide Resolution No.121/04, dated 27.09.2017.

- 2.00 The Project Authority has submitted a proposal for diversion of Forest land for use of Non-Forest purpose involved in Towers Construction of LILO on towards location 204, carrying 220 KV Boisar Nallasopara Transmission Line for existing Palghar Substation. Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.
- 3.00 The details of required forest area is as below:-

- 4.00 The Project Authority has given undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted necessary certificates / undertakings and Maps, which are enclosed in the proposal.
- 5.00 The Deputy Conservator of Forests, Dahanu has certified that the provisions of Forest (Conservation) Act, 1980 and its guidelines under the Act have not been violated by the Project Authority.
- 6.00 The proposal is for construction of LILO on towards location 204, carrying 220 KV Boisar Nallasopara Transmission Line for existing Palghar Substation, therefore the compensatory Non-Forest land is not required. The Compensatory Afforestation on the area of double degraded forest land i.e. 1.4 ha. is proposed in Dahanu Division.

The Deputy Conservator of Forests, Dahanu has certified that 1.4 ha. degraded Reserved Forest land in Compartment No. 177, Survey No.125 of Village Avadhani, Tal. Palghar, Dist. Palghar proposed for Compensatory Afforestation is suitable for Afforestation and Management purpose and it is free from encroachment and encumbrances.

- 7.00 The Project Authority has submitted an undertaking to defray the cost of Compensatory Afforestation at the prevailing wage rate.
- 8.00 The area involved in this proposal does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.
- 9.00 The Deputy Conservator of Forests, Dahanu has certified that the proposed area is not within 10 km. of Sanjay Gandhi National Park / Tungareshwar Wildlife Sanctuary and the Project will not have been any adverse effect on the Wildlife within National Park / Sanctuary.
- 10.00 The Deputy Conservator of Forests, Dahanu has certified that the proposed area from boundary of Sanjay Gandhi National Park is 49.50 km. and 30.60 km. from boundary of Tungareshwar wild life sanctuary.
- 11.00 The project involves felling of 25 trees in the area falling in diversion. Girth wise break up of trees are as under. The felling estimate of trees to be felled is enclosed in the proposal.

Mangrove area.

14.00 The Deputy Conservator of Forests, Dahanu has certified that the proposed project is not likely to affect any monuments, site of culture, historical, religious, archeological or

recreational importance.

15.00 The Deputy Conservator of Forests, Dahanu has certified, that no suitable alternate non

forest land is available for the proposal of construction of 0.7000 ha. LILO on existing 220

KV Boisar-Nallasopara transmission line for Palghar substation. The demanded forest area

is barest minimum.

16.00 The Project Authority has not submitted the FRA-2006 certificate from Collector Palghar.

Regarding this, the necessary undertaking by the Project Authority is submitted and the

same is enclosed in the proposal. The Project Authority may be asked to submit FRA -

2006 certificate after Stage-I approval by Govt. of India.

17.00 The Deputy Conservator of Forests, Dahanu has inspected the proposed diversion area on

dated 03.06.2021. The Site Inspection Report enclosed in the proposal.

18.00 As per the recommendation of the Deputy Conservator of Forests, Dahanu, this project is

infrastructure development project hence the proposal is being recommended for approval

and necessary acceptance under Forest (Conservation) Act, 1980.

19.00 Four sets of proposal are enclosed herewith all required documents for further necessary

action. Proposal is submitted online vide No. FP/MH/TRANS/43305/2019.



This project is 220 KV D/C LILO Boisar-Nallasopar substation transmission line; hence the proposal is being recommended and is of diverting the required forest land under Forest (Conservation) Act, 1980 on the following conditions.

- 1) The legal status of forest land shall remain unchanged.
- 2) The area diverted will be used only for purpose mentioned in proposal.
- 3) Cost of Compensatory afforastation to be borne by the Project Authority.
- 4) Net Present Value to be borne by the Project Authority.
- 5) As and when require by the Executive Engineer, M.S.E.T. Company Limited, E.H.V. Projects Division Kalyan will provide the facilities imposed by the Forest Department.
