Inspection Note:-

The proposed site was inspected by me on 18-08-2022. The factual details regarding the proposed site and consequent findings are stated below:-

- 1- The proposed site is situated under Gopalgani Forest Division, Gopalgani. The proposal is regarding establishment of Retail Outlet/Patrol Pump on the approach road of Mohamadpur-Malmaliya-Chapra Road, Mouza-Bhopatpur under Forest Conservation Act 1980 for opening Hindustan Petroleum Corporation Ltd. Retail outlet, which is notified as protected forest. The approach and exit path need diversion of approach road side land. The proposed area is a part of protected forest vide Government of Bihar Notification No. 190 E dated 16-02-1994. The total area required for the project is 0.01515 Hac.
- 2- There is Seven tree found in proposed area of diversion. There is Four tree in Entry point and Three trees in Exit point which would be translocated along the road side near Retail Outlet/Patrol Pump area by user agency (Proposal of translocation plan as per enclosed) and Nine sapling plant situated in buffer area which is outside from proposed area and not to be felted. The road side plantation has declared as notified forest. There is no rare/endangered/unique species of flora and fauna in this area. No archeological site is present near the proposed site.
