It is informed that ETS & DGPS/ GNSS Survey data of the forest land proposed for diversion **in various RFs of Amangal and Shamshabad forest divisions**, for laying of Optical Fiber Cable along the road and within the existing Right of Way in favour of M/s. Telesonic Networks Limited, Hyderabad, which was received through reference cited has been verified and accepted **subject to verification of the absolute location of points by the concerned filed officers.**

It is informed that proxy RF boundaries depicted on topomaps are used for ascertaining the entry & exit points of alignment with RF. The division boundaries are ascertained with the help of available records. The extents of alignment passing through notified forests are estimated as follows:

**The maps are enclosed herewith.** The Chief Conservator of Forests, Rangareddy, District Forest Officer, Rangareddy and Forest Divisional Officers, Amangal and Shamshabad are being requested to include / delete areas, **if required**, after verification, and inform status of Protected Areas and their eco-sensitive zones, **if any**.

The User Agency is advised to submit **one set of proposal** with full justification together with all necessary Information/ documents in hard copy, **for vetting by Nodal Officer for Forest (Conservation) Act, 1980**. On successful vetting, the User Agency is requested to upload the proposal in the Ministry's website i.e., <https://parivesh.nic.in/> besides submission of hardcopies i.e., **(8) sets of proposal in FCA format** addressed in the name of undersigned for processing under Forest (Conservation) Act, 1980 along with all required Information/ documents, including the authenticated maps. If the areas found to be fall in any protected area during the ground verifications, the User Agency is required to submit **(18) sets of proposals in WL format** for processing under Wildlife (Protection) Act, 1972, and to upload the same at <https://parivesh.nic.in/>.

In addition to above, it is requested furnish a demand draft in favour of "Joint Secretary, CEFNARM". for an amount of **Rs.18,000/- (Rupees Eighteen Thousand only)** towards verification and authentication of ETS & DGPS/ GNSS data, along with covering letter addressed in the name of undersigned.
