Hence balance 17.836 ha of forest area for Utility Corridor needs to be diverted in this diversion proposal.
6	Details of forest land involved in the utility corridor beyond 17.836 ha should be mentioned.	This has already been clarified against point No.5 above. An area over 3.264 ha forest area has already been diverted earlier and the same has been mentioned in page no-3 of Form A of this proposal for reference.
7	It is mentioned that the applied forest land in the instant diversion proposal over 17.836 ha is coming within Joda West Iron & Manganese mines of M/s Tata Steel ltd. Earlier M/s Tata Steel Ltd. Sukinda Chromite Mines has also applied for diversion of 730 ha forest land in which 41.911 ha forest land proposed for Road/Conveyor corridor/power transmission line vide Proposal No FP/OR/MIN/16451/2015 for their Joda West Iron &Mn Mines, which is under process. it is not possible to process two numbers proposal simultaneously for the same forest land which need to be clarified.	Commissioning of Over Land conveying system(OLCS) as well as laying of 33KV line is an integral part of Khondbond Expansion project. Expeditious completion of the project is critical in order to meet the enhanced iron ore requirement of Kalinganagar, Jamshedpur and other steel units of the company. Hence this proposal for the forest land involved for the project within JodaWest Mn lease has been submitted separately for seeking expeditious and favorable consideration. Moreover, the justification of the same has been elaborated at Page No- 5 of the FDP for this project.
8	It is mentioned in DP that the forest land over 3.264 ha(RF-1.80 ha+DLC-1.464 ha) out of the total forest land required for utility corridor within Joda West Iron& Mn mines of M/s Tata Steel Ltd. Please mention the purpose wise breakup of the approved forest land of 3.264 ha.	Diversion of forest area over 3.264 ha has already been approved by MOEF&CC. and the land use indicated in the mining scheme and approved by IBM is for infrastructure (work shop, conveyor corridor, office, WTP etc.). and approved map is enclosed at plate No-6 of FDP for information and reference
9	Prior recommendation of national board of wildlife and prior leave of the supreme court of India if the activity is to be taken up in national park/sanctuary or parts thereof.	The project area does not form a part of any National Park/Wildlife Sanctuary/within any Ecosensitive zone. The nearest protected area i.e. Karo-Karampada Elephant Corridor is at distance of about 12.70 km, Simlipal Tiger Reserve is at a distance about 38km and Telkoi-Pallahara elephant Corridor is at distance of about 55km from the proposed project. Hence clearance from National Board of Wildlife and prior leave of Supreme Court of India is notrequired. A Certificate to this effect has been attached at Annexure - 11of the FDP.
