Hindustan Petroleum Corporation Limited (HPCL), a Government of India Enterprise, proposes to lay a grid of Gas Pipeline for transportation of natural gas from City Gate Station to various CNG stations and other consumers like PNG (D), PNG Commercial, PNG Industrial for city gas distribution in the Geographical Area (GA) of Sonipat - Jind (Haryana) based on PNGRB authorization.

In the 9th round of bidding conducted by Petroleum and Natural Gas Regulatory Board (PNGRB) for CGD network. HPCL emerged as successful bidder in Sonipat (except area already authorized) and Jind Districts (Sonipat-Jind GA). PNGRB vide letter dated 26.09.2018 has authorized HPCL to lay, Build and Operate CGD network in Jind - Sonipat GA (Haryana).

All transportation will be through underground pipeline. **So, only 1 employee will be permanent for monitoring.**
