Please refer to GOI (MOEF) Central Zone DehraDun office letter No. 8B/HP/06/123/2019/F.C/2336 dated: 17/01/2020, addressed to Nodal Officer, Shimla with copy to your office & others on the Subject cited above. In this regard the Observations are being attended as under:-

For the query raised at point No.3, we would like to mention few points in detail to justify the present alignment and the need of the present proposal.


1. It is informed that the proposal has been prepared by making thorough examinations of Geographic Conditions and keeping in view of the needs of the people residing in the area. the proposal is of much importance not only to the villages being connected , but also to the people living in the adjoining area as the link will be connecting the people residing on both the side of the proposed road i.e Village Luhardi, Troh and Behal also will be benefited including Pairi, Pasta and Hawanoo .
2. The alignment is proposed to connect village Pairi with Pasta and Hawanoo and the same will serve as an inter-link road.
3. The alignment is proposed along with Govt. High School Pasta which caters to the children's of the adjoining villages namely Hawanoo, Behal, Troh, including Pasta, Pairi and Luhardi.
4. The link will give access to the Panchayat H.Q situated at Pairi. As at present people have no road connectivity for the same.

5. The link will serve as shortest route to Tehsil H.Q and Medical College Ner Chowk which at present is the only Hospital for the People residing in and around the area proposed for the construction of the said road.
6. Further the proposed alignment will inter link the Ratti Troh Pipil road and Mandi Rewalsar road with Talyahar Pairi road thus making an easy and convenient passage to the people residing in and around the area of the said proposed road.
7. To clarify the above points the population and various important locations including the existing roads net work have been marked on the kml. and have been uploaded on the portal.
8. Some portion of the road has already been constructed so at this point of time it is not possible to change or re-align the said alignment .even people have transferred their lands and the same has been transferred to the HP.P.W.D. Hence keeping in view of, the forest land proposed for diversion is justified and the barest minimum.

Further for the query raised at Point No.1 and Point No.2 we wish to inform that Point No. 1 pertains to DFO Mandi. For Point No.2 we would like to state that cross sections of the roads indicating the dimensions have already been submitted to your office before.


It is therefore, requested that necessary permission for the mentioned proposal may be accorded at your earliest so that work of the above mentioned road could be executed smoothly being time bound project.

An early action in the matter is solicited please.
