- (d) The discussion decisions on such proposals had taken place only when there was a quorum of minimum 50% of the member of Gram Sabha Present.
- (e) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Grama Sabhas have given their consent to it.
- (f) The rights of Primitive Tribal Groups and Pre-Agricultural communities, where applicable have been specifically safeguarded as per section 3 (1)(e) of the FRA
