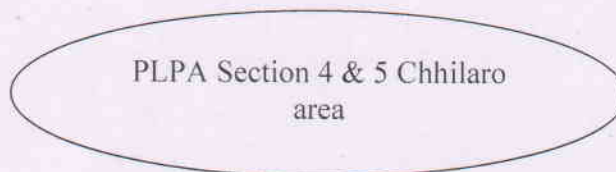
LOCATION MAP
