1. Kindly recall the discussion in the meeting which was held at Jammu on 13.04.2013 with Cabinet Secretary ,Member Electrical, Railway Board and other high officials regarding:-
 - (i) Signing of MoU between Konkan Railway Corporation Ltd. (KRCL) and Power Development Department (PDD), J&K for laying of 132 KV D/C Transmission lines to Reasi and Sangaldan.
 - (ii) Sharing of cost of higher capacity Transformer at Barn & Udhampur Grid Stations for augmentation of capacity, to meet power requirement Railway at Reasi and Sangaldan.
2. During the discussion for item (i) it was decided that there was no need of signing MOU between two organizations, work will be taken up on depositing of amount by Railways to PDD/J&K.
3. Further for item (ii) you were kindly agreed to examine for sharing the cost of augmentation proportionately and convey your decision.
