13 Recommendation for the committee:

Construction of Solag Rorri, Kohal to Jurasi road km. 0/0 to 5/120 in Distt. Bilaspur (H.P.) is under NABARD the involvement of forest land in this road is 0/0 to 5/120 km. This old path required to be windend to make it motorable. The status of land is undemarcated protected forest hence approval under FCA Act 1980 is required for this work. DPR amounting to Rs. 233.73 Lac is prepared under NABARD by the department and is already submitted to S.E. office which is received back with some observation regarding land status. The case recommended for approval under FCA 1980. The damage restoration work under soil conservation / Bio-Engineer etc will cost Rs. 233.73 Lac
