13 Specific recommendation of DCF for acceptance or Other-wise of proposal with reasons.

The proposal is recommended for acceptance, as the proposed approach road is a matter of public importance.

Kharadi, Taluka-Haveli, Distract-Pune is situated on the bank of Mula-Mitha. The village was included in Pune Municipal area in 1997. Most of area of Kharadi is converting rural to urban area and it is developing fast in the fields of Education, Market, Medical facility, and IT industrial sector.

Forest land to construct internal D. P. road known as "Wagholi to Kharadi (by Info Tech Park) road" for non-forest purpose. i.e. Constriction of approach D. P. road connecting Kharadi Gaothan to East part of kharadi, Wagoli, Manjri, Taluka-Haveli District - Pune. Length & Width of the proposed road is 180 Mt x 30 Mt. = 0.54 Ha, Which is passing through the Forest Gut No 74.

As area include in Municipal area, development plan is prepared as per Town planning Guideline. There is existing 6 Mt. Road is available, but this road divide forest land in two part and it have curve in forest area. So as per planning the new D. P. Sanction road aligned on one side on the boundary of the forest. As per local situation, there is no better option other than sanction D.P road.

This D. P. Road will be useful for nearby villages, Wagholi Manjri & it play role as parallel road to Pune -Amhadnagar Highway.

There is old road about 300 Mt. long X 6 Mt. Wide. Passing through Kharadi Forest Gut no 74. Due to the existing road Forest area divide in to two parts. Now proposed D. P. Road is passing on

the forest boundary, & the total length in forest land is 180 Mt. This is shortest distance. There is no alternative because river Mutha is on one side & industrial I. T. Free Zone Building on other side of forest land.

The proposed D. P. Road is comes under PROJECT MANAGEMENT CELL OF Pune Municipal Corporation. This P. M. Cell is mainly working on the works under centrally sponsor Scheme i.e. Jawaharlal Nehru National Urban Renewal Mission scheme of GOI. The proposed road will be constructed by using Cement & not by using asphalt.

As in guideline dated 7/2/2013 - about Modification in para 4.4 and 2.2(ii) As the D. P sanction road passing through Forest & non-forest land. There is excising old road & upgradation work of this road on non-forest land was carried out. This was important for people. Kharad Gut no 75 land is property owned by Pune Municipal Corporation. & Gut no 74 is Reserved Forest. The work was not started on forest land as per instruction given by Forest Department. Project Authority has stopped all work on non-forest land & up to today the work is not restarted.

There is no alternative non-forest land available and the area is to be diverted is not sensitive and hence will not have any adverse effect on the ecology of area. The concerned area has been visited on Dt. July 2015. Hence this proposal is recommended.
