- 1- 3.83 Ha land was given by LADC. KML file attached.
- 2- 0.5329 Ha land was given by Land revenue & settlement dept. Govt. of Mizoram in Lunglei Dt mutated the land including other proposals in which 2 are got stage II approval and one is still waiting for stage one approval excluding this proposal. NOTIFICATION

No. K. 12011/8/2019-REV: Whereas area of deemed forest within Lunglei District to be diverted for the NH-54 project has been corrected from 19.31 Ha to 8.83 Ha, as a result of which the total deemed forest area to be compensated has come down from 25.03 Ha to 14.57 Ha, and the additional area of reserve forest to be compensated is 0.78 Ha, and the total area diverted is 15.35 Ha instead of 25.83 Ha;

Now, therefore, in supersession of the earlier notification vide even No. dated 5th November, 2019, exercising the power conferred under section 14 of the Mizoram (Land Revenue) Act, 2013, the Governor of Mizoram is pleased to mutate an area of **15.35 Ha.** of non-forest land out of the land bank as specified in the Schedule below, for Compensatory Afforestation in lieu of the area to be diverted from forest areas and deemed forest areas for the purpose of widening and upgradation NH-54 (Aizawl-Tuipang):




