

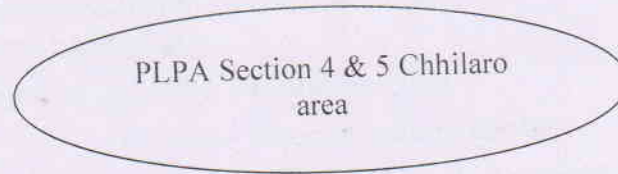
### LOCATION MAP
