MEMO to the Chief Engineer  
Hisar Division

M/s Indian Oil Company, Hisar has applied for issue of NOC for the installation of a petrol pump at the premises of Haryana Agro Corp. Ltd, Hisar at the site as proposed in the map, situated at Hisar-Sirsa road, opposite New Gram Market, Hisar (Khasra No. 1480- 1481, at the land purchased by the Haryana Agro Industries Corp. Ltd from the G.L.F., Hisar under Rule 144 of the Petroleum Rules, 1976.

2. There is no objection for the installation of the proposed petrol pump at the site shown in the map and as per detail given above, subject to the fulfillment of the following conditions:-

1. The NOC granted by this office will be liable to be withdrawn/cancelled as soon as the right of land use ceases, change of circumstances and interest of Public/Govt.
2. All the proposed fire fighting equipments, by the local Fire Officer shall be provided at the site as per detailed given below:-
  - 1- DCP fire fighting equipments of 10 Kg capacity each.... 8(eight)
  - 2- AFFF fire fighting equipments of 9 litre capacity each.... 4(four)
  - 3- Sand Buckets on stand with red ink " FIRE" at the site. 12(twelve)
  - 4- " No Smoking " board shall be displayed at the site.
  - 5- All the equipments must be of ISI mark and these should be got re-filled after every use and at the end of each year as usual. The workers of pump must know the working of these equipments and if these are not round placed at the site, then action regarding report for the withdrawal/cancellation of the NOC shall be taken.
- 3- Ex as per condition of DFO, Hisar, the pump will be installed at the own-land of the applicant and land of Forest Department shall only be used for passage, on receipt of Govt. sanction
- 4- As per condition of XEN, PWD, & R, Hisar, the oil company/applicant will sign the agreement with the XEN, PWD, & R for using the access from this land
- 5- The lease or land agreement will be produced in this office (office of D.M., Hisar) for record.
- 6- The oil company/applicant will stick to their undertaking given in this office.

7- As per above instructions, the oil company applicant will provide modern system of pollution checking of vehicles by providing Video Cameras at the site. Other directions of the Administrative Office will also be complied with.

8- Above all, the Oil Company/applicant will be bound to comply with all the conditions of the department concerned, at present, and in future also, and if it is found that any of the conditions have not been complied with then the NOC granted by this office shall be liable to be withdrawn/cancelled without giving any further opportunity to the oil company and the company will then surrender the NOC in this office and will stop functioning of the pump, if started, forthwith without any further arguments.
