It is to inform that, the original AA&FS for Zojila Tunnel Works was issued by MoRTH on 18.01.2018 excluding approach road. Subsequently, the project was reconfigured as Integrated Project of Zoji La Tunnel and approaches from Z-Morh to Zojila with Avalanche Protection Works. An expert committee was constituted by MoRTH and their recommendations were submitted to Hon'ble Minister Road Transport & Highways for approval.

2. Therefore, approach from Z-Morh to Zojila was added by MoRTH on the basis of recommendation of the Expert Committee and approved by Shri Nitin Gadkari, Hon'ble Minister Road Transport & Highways vide e file No. 184133 dated 23.05.2020. Subsequently, NHIDCL was directed to invite the bids for the subject mentioned work including Approaches from Z Morh to Zoji La tunnel.

3. Therefore AA&FS issued earlier is applicable and valid for Integrated Project including approach from Z-Morh to Zojila.
