ORDER:-

The Hon'ble Chief Minister, Telangana, during his visit to Nalgonda District on 29.12.2021, has directed the E.E. R&B, Nalgonda to identify suitable land near Collectorate, Nalgonda for construction of permanent Helipad.

vide reference 1st read above, the EE R&B, Nalgonda submitted proposals to the Principal Chief Conservator of Forests, TS, Hyderabad for diversion of Forest land to an extent of 1.1509 Ha at Gollaguda Reserve Forest for construction of Helipad.

Vide reference 2nd read above, the Principal Chief Conservator of Forest, TS, Hyderabad, has requested to identify non forest CA lands equivalent to forest land proposed for diversion and furnish the details to the concerned CF/DFO/FDO for inspection for assessing the land for raising CA.

Vide the reference 3rd read above, the RDO Miryalaguda has reported that the Tahsildar, A.D.Pally Mandal has identified Government land to an extent of Ac.3.00gts in Sy.No.237 at Chityala Village of Adavidevulapally Mandal for the purpose of Compensatory Afforestation.

Vide reference 4th read above, the District Forest Officer, Nalgonda has been directed to verify the proposed Government land and submit suitability Certificate for

Compensatory Afforestation in lieu of the forest land proposed for diversion in favour of E.E. R&B, Nalgonda for construction of Permanent Helipad.

vide reference 5th read above, the District Forest Officer, Nalgonda, has reported the FRO, Miryalguda inspected the Sy.No.237/2 on 01.01.2022 and found that the proposed land is adjacent to the A.D.Pally Reserve Forest Block, free from encroachments. The tree growth is scrub jungle with density of 0.1 to 0.2 and rocky boulders are present. The landscape and density of vegetation as similar as in Adavidevulapally RF. The plantation is not possible in this land and need to be done in CA DFL site and recommended for chain link fencing around the CA land for improving vegetative growth as the cattle movement is observed over the land and finally recommended the land for Compensatory afforestation in lieu of diverted forest land for construction of permanent Helipad.

In view of the above the proposed land Ac3.00gts in Sy.No.237 at Chityala village of Adavidevulapally Mandal is hereby allotted for Compensation Afforestation to Forest Department of Telangana State in lieu of diversion of forest land in favour of E.E. R&B, Nalgonda for construction of Permanent Helipad.

The Tahsildar, Adavidevulapally is hereby directed to hand over the land to an extent of Ac.3.00gts in Sy.No. 237 at Chityala village of Adavidevulapally Mandal to the Forest department after and mutate the same in favour of the Forest Department in lieu of Forest land diverted in favour of E.E. R&B, Nalgonda for construction of Permanent Helipad after the Stage I clearance is received from GOI and make necessary changes in the revenue record and submit the copies of the relevant Revenue records along with panchanama and mutation copies to the undersigned.
