

The Govt. vide GO Ms.No.699, Panchayat Raj and Rura Development, under PMGSYProposals of 2017-18 dated.16.11.2017has approved administrative sanction an GO.Rt.No.217, Dt:03.04.2018 for Revised Administrative Sanction for laying of BT and maintenance of Roads an GO.Rt.No.178, Dt: 06.05.2020 for Re-Revised Administrative Sanction. The proposed project is one among them.  The existing surface is from km 0/000 to 8/000is trace portion. The project is for New connectivity of the existing road from track to BT Standards. The road passes throug the reserve forest km 0/000 to 8/000. Hence forest clearance is needed in the reach 0/000 to 7/918 ie 7918mt for formation & up-gradation of road to BT standards. It is also an important road connecting these villages to the GudurMandal Headquarter enrouting number of interior villages, and also vehicular movement for transportation of goods.		

2200			available to Ootla Gram Panchayat except the proposed road which leads to Mandal headquarters Gudur .As per Govt. policy all habitations and missing links to be connected. There is no alternative land or route available to connect the habitation, hence the road is proposed through forest.  As per the DGPS survey authentication report, the extent of area passing in the Reserve Forest area is 5.9359Ha. (Length –7918.48mts, Width – 7.50 mts)  As there is no alternative to that for Formation of BT road, proposal is being furnished for diversion of forest land.
