In this regard, some observations have been notified by the Regional Officer, Ministry of Environment, Forest and Climate Change, Longwood Shimla, which has been resolved as under:-

- As per Point No. 1, In this regard it is submitted that the proposed project site for the construction of Himachal Sanskrit Academy Tehsil and District Shimla bearing Kh. No. 160 Mohal Marwag is a Charagah Billa Darkhatan as per revenue record (copy enclosed) which is a wasteland as per 1952 Notification of the Government HP, the legal status of the land for the proposed diversion area is under the ownership of Government of Himachal Pradesh.
- 2. As per Point No. 2, the needful has been done by updating the benficiary villages and the proposed diversion area in the KML file.
