Sir,

NMDC is undertaking iron ore mining operations in the Deposit-14 M.L. area which was granted earlier in the year 1965 for a period of 30 years till 10/9/1995. The lease period was renewed for further period of 20 years i.e upto 11/9/2015 and further extended upto 31/3/2020 under the provisions of M.M (D&R) Amendment Act, 2015. The forest clearance was obtained from MOEF, New Delhi on 18/6/1999 over 322.368 Ha of forest land at the time of 1st renewal of M.L. As per rule 3(3) of Mineral (Mining by Government company), the State Government shall extend the period of the mining lease for further period of upto 20 years i.e upto 2035 w.e.f 11/9/2015. The renewal of ML also requires fresh forest clearance under the provisions of F.C. Act, 1980.

Hence, NMDC is submitting the F.C. Application in Form-B for obtaining Forest clearance for renewal of M.L of Bailadila Deposit-14 over 322.368 Ha forest land in Bacheli forest range, Dantewada Forest Division. The application in Form-B is uploaded in Ministry website.

We hereby request you to kindly accept the online application for further necessary action to obtain Forest clearance for above proposal.
