With reference to your letter and query under reference about the proposal for the diversion of 50.091 ha. Of forest land in favour ITBP. for the construction of Dubling - Rishi Dogri-Lamche Dogri Road 0/00 to 25 Km by CPWD, within the jurisdiction of Kinnaur Forest Division, Dist. Kinnaur, Himachal Pradesh has been scrutinized by your office and we have been informed of some queries on the shortcomings.

4	In the enumeration list of trees filled in the online Part-II, the total number of trees are 122, whereas in the enumeration list placed in the proposal folders the total number of trees are shown 112. Please see to it and recheck.	Trees under Pooh Range = 112 Nos. & Under Moorang Range = 10 Nos. Accordingly Total no of trees = 122 Nos. (copy as on Page No. 85&89), as shown in online Part-II.
5	There is no page number mentioned in respect of the enumeration list placed in the proposal folders in the online-II. Please see to it.	Pertains to the Forest Department.
6	There is no page number mentioned in respect of the check list i.e., non-forest area/degraded forest land indicated for compensatory afforestation in the online Part-II.	Pertains to the Forest Department.

13	The land suitability certificate placed in the proposal at Page 16 is without the date. Please see to it.	Pertains to the Forest Department.

14	The NPV of the forest land has not been worked out properly. The eco class has been mentioned VI and the rate applied to Rs. 8,45,000/- please go through the revised rates of NPV circulated vide MoEF letter No.5-3/211-FC (Vol-I) dated 06.01.2022 and act accordingly.	Pertains to the Forest Department.
15	The FRA certificate of the competent authority has not been placed in the proposal folder, which is mandate.	Application has been made to DC, Kinnaur and in process in O/O DC, Kinnaur. It will be submitted before stage-II approval.

This road is situated within 100Km of aerial distance from LAC with China and sanctioned by Cabinet Committee on Security in Sep 2020. Please go through this. We hope you will find these compliances acceptable. It is requested that forest clearance may be accorded at an earliest please.
