i)	Short narrative of the proposal and project/ scheme for which the forest land is required	:	The main ambition of construction of check dam across Thamiraparani river in between Alwarthoppu and Alwarthirunagari village is for artificial recharge purpose. By this rechargeable scheme, 33 wells located in Alagiya manavalapuram and Alwarthirunagari villages are benefitted both for irrigation as well as drinking purposes. There are 11 irrigation wells, 14 irrigation wells and 8 drinking water wells situated in Alagiamanavalapuram, Alwarthirunagari and Thirukkallur village respectively as such total number of wells available with in the rechargeable zone of this check dam is 33Nos. By Adopting duty of 100 acres/ mcft, the total benifitted (rechargeable) area works out to 1522 Acres.

iv)	Justification for location of the project in the forest area	:	Mainly, it is proposed to construct a check dam for artificial recharge purpose in the surrounding area. Due to numerous drinking water projects, during non-monsoon seasons ,there is a huge shortage of drinking water supply and irrigation in and around Alwarthirunagari village. Based on the repeated requisition from the farmers and public, it is proposed to construct a check dam in order to sustain the water level in the zone of influence and to ensure adequate supply from the TWAD wells located in the upstream of Alwarthoppu bridge.
