MEMORANDUM:

The GOI, MOEF has given formal approval for diversion of 1.915 ha. of protected forest land for spot widening and improving at SH-47, Bavla-Dhokla road, Km. 13/0 to 17/0 in favour of R.&B. Division in Ahmedabad district of Gujarat vide their letter dated 15/01/2008 referred at Sr. (1) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

1. The legal status of the forest land shall remain unchanged.

2. Compensatory afforestation shall be taken up by the forest department over

3.83 ha. degraded forest land(Range- Dholka, Village- Bagodara- Dholka-Kheda road, Ta. Dholka, District-Ahmedabad) at the cost of the project authority within 2 years from the transfer of forest land to the user agency.

All the funds received from the user agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund management & Planning Agency(CAMPA) in A/c No. CA- 1583 of Corporation Bank, Block-11, CGO Complex, Phase-I, Lodhi Road, New Delhi-110 003.


