## **MEMORANDUM:**

The GOI, MOEF has given formal approval for diversion of 9.90 ha. of road side Protected forest land for widening to two lane, on Bavla- Dholka road, from Km 1/00 to 13/00 in favour of R & B Division in Ahmedabad dist. of Gujarat vide their letter dated 23/2/2010 referred at Sr. (1) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

- 1. The legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up over 19.80 ha. of degraded forest land in Survey No. 201, Village- Gogla, Ta. Dhandhuka, Dist. Ahmedabad at the cost of the user agency, within 2 years from the transfer of forest land to the user agency.
  - Prior necessary clearance shall be obtained under Environment Impact Assessment Notification, 2006, if the road is to be tarred/Black topped.
  - Tree felling will be carried out only when absolutely necessary.
- 5. The User agency will develop a place for roadside plantation in consultation with the Forest department and will carry out such plantation at their own cost in the interest of conservation.
