The proposed **Laying of Water Pipe Line From Chambal-Bhilwara WSP (PHASE-I) to Hindoli-Nainwa Pumping Station District -Bundi** alignment hence without forest land involvement can't complete. Considering the selection of the path in the Laying Pipe line of the proposed for “**Laying of Pipe Line Hindoli-Nainwa Water Supply Project District-Bundi From Chambal-Bhilwara WSP (PHASE-I) District -Bundi (Rajasthan)**” minimum forest land has been done. No Alternative routes are available for this. The (Bhilwara Division-0.8676ha. , Ramgarh Vishdhari Tiger Reserve (Core)- 0.5706 ha. & Bundi Division-3.5593 ha) minimum forest land is 4.9975ha. It is proposed that the unavoidable be unavoidable. Keeping in view the prevailing law in the proposed route(Bhilwara Division-0.8676 ha. Ramgarh Vishdhari Tiger Reserve (Core)- 0.5706 ha. & Bundi Division-3.5593 ha) the reserve of 4.9975hectares of forest land has been proposed.
