As per the information provided by the concerned DFO under column 11 of Part-II, the instant proposal involves the violation and the forest land involved in the violation is 0.1677 Ha. which has been done in the year 2007. However, as per the Joint Inspection Report of dated 18.12.2014, there is no observation made by the committee regarding the violation part. The information provided are contradictory.	The required information under column no. 11 of Part-II pertains to concerned DFO Office. Further, list of 2183 cases has been uploaded and the concerned road i.e."  Parech-Dafawage-Karech Road" appeared at Sr. 138. However, the revised joint inspection conducted on dated 25.05.2022 giving the detail of violation has been uploaded against additional

Similarly, the JIR on dated 18.12.2014 has mentioned number of trees felling in the proposed alignment as 60 trees, but the latest Joint Inspection Report of dated 25.05.2022 and further Column 4(ii) Part-II online, the total numbers of trees felling in the proposed alignment is mentioned as 184 trees. The information provided are contradictory.	information detail on the portal.  At the time of JIR conducted on 18.12.2014 there were less trees as mentioned in JIR. But at present saplings of various species have been grown on the spot, hence, there is variation in trees found in it. However, revised Joint Inspection Report conducted on dated 25.05.2022 is final and as per actual condition of the selected patch of forest land. The total number of trees felling in the proposed alignment is 182.

Furthermore, in the detailed report on the violation uploaded (at Sr. No. 5-Additional information of Part-II) by the concerned DFO, it is clearly mentioned at Sr. No. (b) I.e. the name and designation of the officials/persons primary responsible for violation is mentioned as HPPWD/BDO. However, at Sr. No. (c) of the report i.e. regarding fixing the responsibility of violation, it is mentioned as 'Not Possible'. The statements mentioned at Sr. No. (b) of the report, the action is required to be taken by the State Government.
