- **Introduction**

In relation to Tender No. THIRDCALL_02/CEO/CHIPS/SKY/2018, CHIPS has concluded the bid evaluation process for selection of implementation partner for Chhattisgarh Sanchar Kranti Yojana ("CG-SKY Project"), and is pleased to inform that Reliance Jio Infocomm Limited ("RJIL") is hereby declared the successful bidder. Accordingly, pursuant to the terms of the RFP, this Letter of Award ("LOA") is hereby issued to Reliance Jio Infocomm Limited for implementation of the CG-SKY Project, subject to the conditions as set out in this LOA.

- **Consideration**

For implementation of the CG-SKY Project as envisaged under the Tender Documents (including the RFP and the draft Agreement) in detail and strictly as per the conditions, timelines, technical requirements and standards of performance set out therein, the consideration paid by CHIPS to RJIL shall be in accordance with the Bid submitted by RJIL dated 02 April 2018 ("Consideration"). The Consideration shall be inclusive of all taxes and other levies i.e. excise duty, freight, sales tax, octroi, insurance, customs, service tax, etc. Any revision in the tax shall be payable as per the terms and condition mentioned in the Tender Documents.

- **Acceptance**

In accordance with the terms of the RFP, within 3 (three) business days of the receipt of this LOA, you are requested to sign and return a duplicate copy hereof as its acknowledgement recording on the duplicate copy of the LOA, "Accepted Unconditionally", under the signature of the Authorized Signatory of CHiPS. If the duplicate copy of the LOA duly signed by you is not received by CHiPS within the stipulated date i.e. 19/04/2018, then CHiPS may, unless it consents to extension of time for submission thereof expressly in writing, appropriate the earnest money deposit submitted by RJIL ("EMD") as damages; and in such an event, CHiPS shall be free to consider the next eligible bidder.

- **Other Material Conditions**

RJIL is required to execute the Agreement for the CG-SKY Project with CHiPS within 10 (ten) days from the issuance of this LOA i.e. 26/04/2018; and is further requested to conduct site survey and submit Network Augmentation Plan for Cell-sites as per RFP guidelines within 15 (fifteen) days from date of signing of Agreement i.e. by 01/05/2018, for validation and approval by CHiPS.

RJIL is also directed to submit *performance bank guarantee/PGB 1* for the required amount in the form specified in Clause 4.21 of the RFP, within 7 (seven) business days from the date of notice of this LOA i.e. by 23/04/2018.

This LOA is issued subject to/in anticipation of complete and unconditional compliance by RJIL with all the terms and conditions set out under the Tender Documents as may be required to be fulfilled during the stage between LOA issuance and Agreement execution and thereafter, including submission of the STQC Report in relation to Smartphone I and Smartphone II with the RFP requirements; and the LOA may be revoked or rejected at any time by CHiPS in its sole discretion.
