TO WHOMSOEVER IT MAY CONCERN

In compliance of the ministry of environment and forest (MoEF), Government of India letter No 11-9/98-FC (Pt.) dated 3rd August, 2009 and dated 5th February, 2013 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest dwellers (Recognition of forest Rights) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes. in further modification of above said letters, MOEF exempted the requirement of initiation and completion of process for recognition and vesting of forest rights of scheduled tribes and other traditional forest Dwellers in case of Linear Projects vide ministry of environment and forest (MoEF) Government of India's letter no. 11-9/98-FC (pt) dated 28-10-2014.

It is further certified that-

- a) An area of 99.328 ha. at NH-91 (Naganj to mitrasen) section from km. 289.00 to k.m. 356.00 and at four laning with paved sholder is required in tehshil chhibramau and kannauj distt. Kannauj (propose for diversion of forest land)


The above area falls within the jurisdiction of tehsil Chhibramau and kannauj.

- b) The proposal does not involve recognized right of primitive Tribal groups and traditional forest dwellers communities

- c) The 'Forest land' to be diverted is a plantation and notified as 'Forest' less than 75 years prior to 13th December 2005 and located in villages Mighouli, Tadha, Prempur, Barua sabalpur, udhannapur, Ghiloy, Ghiloy Khas, Vishanpur, Hasilpur, sarai Sunder, Khudawa, Akbarpur, Jasua Mai, Salempur, Shahjahanpur, Kheda Jagdishpur, Chittarpur, Sulahamai, Karmullapur, Hasanpur Sani, Aurai, Sarai Daulat, Babrapur Makhadumpur, Jagatiapur, Sarai Prayag, Terajakat, Rajlamau, Ismailpur, Khande dewar, Dundwa Bujurag, Junedpur, Majh Purwa, Gadhiya Kachapura, Safipur Japti, Jalalbad, Tilpai Digsara, Fatehpur, Jewan, Vasheerapur Bhat, Sarontop, Panwara, Jalalpur, Bhapur, Mahmoodpur Painth, Rampurmajara, Gandharapur, Karanpur jolly, Haibatpur, Gandharapur, Chouki Mustafabad, Nasarapur, Ahmadpur Rauni, Manpur, Balarpur, Manpur, Jalalpur, sarman, Chodhariyapur Bangar, Ritukala, Bahadurpur Ujaina, Rajgirhar, Manimau, Dandaora Khurd, Dandora Bujurg, Musafirpur, Sakari Khurd, Mitrasenpur, in no recorded population of Scheduled Tribes or traditional forest dwellers is available as per the census of 2001 and the census 2011. The requirement of forest land as proposed by the user agency is barest minimum.
