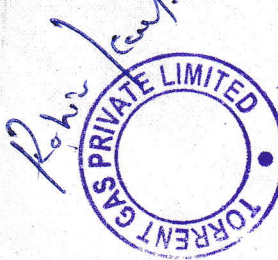

Subject: Permission to lay steel pipelines 12 inch parallel and across the PWD Road (within ROW) falling route pipeline from Thapar University- Nabha and adjoining areas falling under PWD to provide the Natural gas to Domestic households (**Crossing Birjahlan distributary Q=9.77 cs, Dhablan distributary Q=39.90cs, Ramgarh Distributary Q=32.53cs, Rohti distributary Q=17.12cs**)

Reference: Your Office letter dated 13/10/2020

On your reference and subject cited above the NOC is issued on the basis of report no:- 433 dated 10/05/2021 received from Sub Divisional Officer, Lehal subdivision I.B. Patiala and guidelines issued from director C.D.O under the following conditions:

1. The level of Gas pipes will be in accordance with the bench mark of canals and 4 meter below the design bed level or scoured bed level, whichever is lower and shall be laid by trench less method.
2. The pit for Gas pipeline will be dug at sufficient distance away from outer toe of banks of Minor/Branch and canal land boundary so that phreatic line is not disturbed at any cost.
3. By laying the pipeline below the canal/Minor/distributary bed, it will be ensured that normal functioning of canal is not affected and irrigation supply is not interrupted.
4. The work will be carried out as per instructions issued at site under the supervision of concerned Sub Divisional Officer, Lehal sub division I.B. Patiala of Punjab Water Resources department.
5. In case the pipe lines are affected due to future development & improvement of Canal system by Punjab Water Resources department, the cost of laying pipe lines for relaying, rerouting/dismantling of pipeline will be borne by concerned entity.





6. The cost of laying pipe line/temporary/permanent infrastructure will be borne by entity.
7. All temporary structure constructed during the execution shall be removed and the site shall be cleared of all the dismantled material immediately after the laying of pipeline.
8. Special precaution will be taken by concerned Entity for safety of canal/canal bank and other infrastructure in the vicinity of site where crossing works is being undertaken. Clearance will be obtained by Entity before leaving the sites after laying of pipelines from this office.
9. In case any accident occurs during or afterwards due to laying of pipe Lines, the Entity will be responsible for the same and will pay for losses.
10. There will be no interference to the pucca works in the vicinity of proposed crossing site.
11. The entity will abide by the rules/regulations/policy of Punjab Water Resources Department.
12. The entity will deal any court case or any objectionable statements raised by any other private or government firm at its own level.
13. The lease of Government land and supervision charges and or any other expenditure as per departmental rules will be paid by the Entity.
14. Clearance/NOC from other departments, if required shall be taken by the company at its own level.
15. The pillars, if any, depicting the gas pipe line should be installed outside the canal land boundary.

The NOC for laying the pipeline below the above mentioned canal be issued at our level keeping in view the above and any other conditions required from field considerations.
