As you're aware, we, Power Grid Corporation of India Ltd (a Govt of India Enterprise) under Ministry of Power (MoP) is entrusted with the task of establishing 400 kV D/C Quad transmission line from Tumkur (Vasantanarsapur) to Yelahanka under the Southern Region System Strengthening Scheme 13 (SRSS-13) vide MoP, Govt of India approval No.11/4/2007-PG dated 03.12.09. This project is envisaged to enhance the power scenario of southern states and further strengthen the National Grid. It's fast progressing with the kind support of state government.

In sy no.79/P1, sonnenahalli village, Yelahanka Taluk, Bangalore Urban, the line is crossing the proposed "Deemed Forest", which as per RTC is a revenue / Govt. land; but maintained by KFD. This came to light after erection of towers on either side of this area (outside the boundary). The line is crossing 213m above this plantation & is unavoidable due to insufficient right of way. Accordingly, in compliance to your letter ref (i) forest clearance application under FC Act 1980 is submitted to Karnataka forest department vide ref (ii) above & is accepted by them vide email dated 09.12.19, copy attached along with the complete set of application in 5 no's (copies to DCF, CF, APCCF, SG & RMoEFCC, Gol).

As per guidelines of Ministry of Environment, Forests and Climate Change (MoEFCC) Govt of India dated 05.07.13 and 28.10.14 on FRA, request letter is submitted to DC, Bangalore Urban for the certificate in compliance to the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006. This will be submitted once received from the official.

Hence, we request to kindly process the application further and forward your kind recommendation for further processing of Stage 1 clearance.


As you're aware, we, Power Grid Corporation of India Ltd (a Govt of India Enterprise) under Ministry of Power (MoP) is entrusted with the task of establishing 400 kV D/C Quad transmission line from Tumkur (Vasantanarsapur) to Yelahanka under the Southern Region System Strengthening Scheme 13 (SRSS-13) vide MoP, Govt of India approval No.11/4/2007-PG dated 03.12.09. This project is envisaged to enhance the power scenario of southern states and further strengthen the National Grid and is on the verge of completion, with your kind support.

In Sonnenahalli Village after erection of towers on either side of a plantation area (Survey No. 79/P1 as per RTC a revenue / Govt. land but being maintained by Forest department) it was informed by forest department that this area is under notification to become a 'Deemed Forest' and they have demarcated the same, recently with chain link fence. The line is crossing 213m in this plantation & is unavoidable due to insufficient right of way. Accordingly, forest clearance application under FC Act 1980 is submitted to Karnataka forest department vide ref (i) above & is accepted by them vide email dated 09.12.19, copy attached with complete application.

As per guidelines of Ministry of Environment, Forests and Climate Change (MoEFCC) Govt of India dated 05.07.13 and 28.10.14 (copies enclosed) a certificate from the District Collector in compliance to the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 is required for further processing of forest clearance application. A copy of the certificate format is enclosed for ready reference please. Accordingly, we have requested the same vide our letter ref (ii) above. Hence, we request to kindly provide this certificate so as to process the forest clearance application further.


