

Sub: Request for identification of degraded Forest Land for Compensatory Afforestation.

Dear Sir,

An Application for diversion of 133.69 Ha (46.17 Ha notified forest land + 87.52 Ha Jungle Jhari land) in leasehold of Muraidih Colliery was submitted online on 09.03.2020 vide ref no. FP/JH/MIN/44804/2020.

As per point no. 2.5 (i) (f) of Chapter 2 of Handbook of guidelines for effective and transparent implementation of the provisions of Forest (Conservation) Act, 1980, Compensatory Afforestation (CA) shall be raised and maintained at the cost of the user agency on degraded forest land twice in extent of the forest area diverted in cases of the projects implemented by the Central Government/PSUs, excluding Central Govt./Central PSUs Projects implemented by/through State Government and State Sector Projects implemented by the Central Government/PSUs.

For the compliance of above, about (133.69*2 =267.38) 268 Ha forest land/ degraded Forest Land with Crown Density below 40 % under the administrative control of forest department is required for Forest diversion of Muraidih Colliery.

Hence, it is requested to kindly identify the degraded Forest Land for Compensatory Afforestation (CA) and demarcate the same on Mouza Plan for the timely compliance from our end.
