Sub : Permission to M/s IGL for laying of underground pipe laying 300mm (CS) by HDD/Trenching method along NH-19 (Kanpur - Prayagraj) between Km. 486.000 to Km. 552.000 (LHS) in District Fatehpur in the State of Uttar Pradesh.

Sir,

This is regarding the approval for granting permission for laying of underground pipe laying 300mm (CS) by HDD trenchless method along NH-19 (Kanpur - Prayagraj) between Km. 486.000 to 552.000 (LHS) in District Fatehpur in the State of Uttar Pradesh as submitted by you.

In view of above, the Competent Authority has conveyed the approval and further Competent Authority has authorized Project Director on behalf of NHAI for signing of License Agreement with the applicant. The above approval is subject to ensure following compliances before according the permission:-

- i. To submit an additional undertaking from applicant that the highway development work is under construction, hence the applicant should not obstruct the construction work.
- ii) The NOC is being issued on the basis of confirmation of license fee deposition in "Bharat Kosh" through online.
- ii. The laying work will be done as per the proposed / agreed location route and as per proposed layout plan.
- iii. The License shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
- iv. Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- v. Undertaking to the following effect may be submitted and made part of the agreement:-
 - a) Three copies of "As Laid Drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.
 - b) The permission may be terminated immediately on violation of the agreed terms and conditions.


- c) The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.
- d) Ensure that the submitted Agreement is in prescribed format as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the applicant, and BG be obtained as per the Circular.
- e) Work programme may be submitted and ensure timely completion.
- f) The compliance of various undertakings given by the Applicant may be ensured before and after signing of License Agreement, as the case may be in the interest of Safety of road users and NHAI.
- (v) Laying work should be carried out through as per Ministry Circular dated 20.11.2016.
- (vi) It shall be the responsibility of the applicant to ensure the safety and manoeuvrability of Highway Traffic during laying.
- (vii) The approval is based on the submissions made by the Applicant as verified by the PD, PIU-Kanpur. The applicant is responsible for details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- (viii) In view of any future development requiring necessary alteration, including complete removal or shifting of the OFC Cable, the same shall be carried out by the applicant at its own cost to the satisfaction the Highway Administrator.
- (ix) In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
- (x) IRC:98-2011 be complied wherever applicable.

Further, the Bank Guarantee No. LOBG201012001396 amounting to Rs. 66,00,000/- issued by IDFC First Bank Ltd., valid upto 16.03.2021, if the work is not completed within time, the same shall be extended by the applicant.

In view of above, it is requested to furnish all the above documents/ undertakings at the earliest, so that the agreement for above work may be executed. It is further requested not to start any construction activity before execution of the agreement.

The above agreement will be executed in triplicate on stamp of Rs. 100/- and each part to this agreement may retain original with stamped copy.
