This expansion introduces practical limitations that impede the restoration of forest land within the scope of the upcoming mine expansion. Given the anticipated advancement, facilitating the reclamation of forest land within this expanding operational area becomes unfeasible and cannot be implemented in the MP&MCP of Bhubaneswari OCP, 30 Mty (Rev-2).
