1. With reference to letters referred above, and minutes of the SLTC meeting dt. 12.07.2017 held under the Chairmanship of Principal Secretary to Govt. Haryana, Urban Local Bodies Department cum-Chairperson of the SLTC (circulated vide DULB office letter TA-II/HUIDB/2017/7969 dt. 17.07.2017), the approval of State Level Technical Committee to the acceptance of the tender of M/s KKSIL - Triveni JV (M/s KK Spun India Ltd. and M/s Triveni Engineering & Industrial Ltd.) is here by conveyed for an amount for Rs. 84,50,00,000/- (Rs. Eighty Four Crores Fifty Lakhs only) (i.e. Rs. 118,70,13,587/- X (100-28.813)/100 = 84,49,99,362/- say Rs. 84.50 Cr.) as per details given below:-

2. The details of the rates quoted by your agency for each item are given in Annexure-I, All pages have been signed by PDMC, SDE-I & EE-I, ULB for verification and attested by Superintending Engineer and Chief Engineer, Municipal Corporation, Karnal.
3. Time Limit : 18 months to be reckoned w.e.f 01.08.2017.
4. The expenditure of the total work is restricted to an amount of Rs. 84.50 Cr.
5. The work will be taken in hand after approval of design and drawing by competent authority as per agreement
6. No change of specification will be allowed to be done on the work by Chief Engineer/Superintending Engineer/Executive Engineer, concerned, at his own level, without the prior permission of Head Quarter in writing.
7. There will be no excess over the provision made in the administratively approved estimate of work which will be ensured by Executive Engineer, concerned.
8. The work will be executed under control of Engineer-in-Charge and closely monitored by PDMC of ULB under AMRUT, IRMA, senior officers of MC Karnal and SE PHED, Karnal.
9. All terms and Conditions of DNIT (Detailed Notice Inviting tender) contained under Volume- I to IV are integral part of this work order.
10. The work should strictly be executed in accordance with the P.W.D. Specifications.

11. The work should strictly be completed within the time limit given above failing which action will be taken under clauses of DNIT contained under Volume- I to IV and as per terms and conditions of said work.
12. All type of machinery (Tools & Plants) and other construction material required for execution shall be arranged by agency and no material will be supplied by the Department.
13. In case of any dispute, if arises under the law and contract in question, shall be dealt under the conditions of the DNIT.
14. Security, GST, Income Tax and Labour Cess etc. applicable as per Govt. Norms will be deducted from the payment bills of the Agency.
15. **The executing agency will be held responsible for any fault/damage observed in the work for one year period from the date of completion and the defects will be got rectified by the agency free of cost for one year from the date of the completion.**
16. **Security Deposit and Performance Guarantee**

I. Security Deposit

The earnest money of successful bidder @ 2% shall be retained by the corporation against the Security Deposit. The additional security @ 5% of gross value of every running and final bill of the contractor shall be deducted, making the total deduction as 7% against the security deposit.

II. Performance Guarantee

The performance guarantee shall be 3% of the contract value (excluding O&M cost). the performance guarantee of 3% can be deposited by the agency within 7days of the allotment of work in the form of bank guarantee as per format at Annexure-14 of DNIT. The BG should be issued by any nationalized / schedule bank and shall remain valid up to 60 days beyond defect liability period. Bank Guarantee submitted against the performance guarantee, shall be unconditional and en-cashable / invokable at Town for which Bids are invited or at least at the concerned district head quarter when presented in specified Branch Office.

III. Release of Security Deposit and performance Bank Guarantee

The total deduction (2% earnest money, 3% performance guarantee and 5% security deposit) shall be released after completion of defect liability period of 12 months of the work.

You are hereby instructed to start the above said work and execute an agreement with Municipal Corporation, Karnal within 15 days on non-judicial stamp paper of Rs. 100/-. By issuance of this work order your contracts concluded and time limit shall be reckoned from the date of 01.08.2017.
