- Adequate number of rumblers / speed breakers and underground passages shall be provided to facilitate movement of wildlife and to avoid accidents.
- All the material required for road work shall be brought from outside and no material shall be collected from Reserve forest or reserve land.
- 7. For any kind of blasting and quarrying prior permission shall be obtained.
- All DGPS surveyed points shall be clearly demarcated on the field and proposed alignment shall be followed.
