i.	The proposal is for a non-site-specific activity. According to the guidelines dated 24.01.2022, not-site specific activities are not allowed on forest land.	Mostly the area of Mussoorie town falls in notified area. The proposed land is situated in deamed to be forest. Proper site of the STP required a comprehensive study of the area to be served, to ensure that entire area can be adequately drained. The geographical structure and the slope of the Kampty fall zone does not permit to construct STP other site than the proposed site. There is no other land available to construct STP. Hence only proposed site is fasible for STP.
ii.	Instead of justifying the proposal activity, the benefits of the proposal have been submitted. The state government is requested to provide clear reasons for not selecting non-forest land for this purpose.	Mostly the area of Mussoorie town falls in notified area. The proposed land is situated in deamed to be forest. Proper site of the STP required a comprehensive study of the area to be served, to ensure that entire area can be adequately drained. The geographical structure and the slope of the Kampty fall zone does not permit to construct STP other site than the proposed site. There is no other land available to construct STP.
