**JUSTIFICATION FOR LOCATING THE PROJECT IN FOREST LAND**

Project : Diversion of 1.33 Ha of forest land near Adkoli Cross in F.Sy No. 54A of **Kansur** village of Siddapur Taluk, Uttara Kannada District for establishing 1X10 MVA, 110/1 KV Substation along with construction of 110 kV LILLO line from Jog-Sirsi DC line using Lynx conductor for a distance of 0.3 km in favour of the Executive Engineer (Electricals), Major Works Division, Karnataka Power Transmission Corporation Ltd (KPTCL), Uttara Kannada District, office at Vidyut Nagar, Karwar Road, Hubballi.


Reference : Proposal No. FP/KA/Substation/36164/2018 dated: 27-09-2018.

The Technical Coordination Committee of KPTCL has approved the project in the 74<sup>th</sup> meeting dated 20.06.2017. The TCCM has approved the proposal to improve the voltage regulation of 11KV lines and to improve the quality and reliability of power supply in the area around Kansur. Hence, the project has to be implemented at Kansur. Minutes of the 74<sup>th</sup> Technical Coordination Committee meeting of KPTCL is uploaded.

In justification to the identification of Forest land for the project, Panchayat Development Officer, Tarehalli- Kansur Grama Panchayat, Siddapura Taluk, Uttara Kannada district, has stated vide letter no. 33 dated 21.01.2019 (copy uploaded) has stated as follows:

- 1) No private land owners are available for sale of revenue land around Kansur village. Also, it is stated that no Government land available around Kansur village.
- 2) Establishing substation at Sy. No. 54A of Forest land is feasible as the proposed land is having only Acacia plantations. Also, the proposed land is near to the existing line and attached to the road which is suitable for transportation.
- 3) Establishing substation at Kansur will reduce interruptions and improve power supply situation around Kansur village and Water supply installations.

It is confirmed in the above letter of Panchayat Development Officer that no alternate land is available and hence requested for diversion of the proposed 1.33 Hectare of forest land required for the subject work.
