The Essential Details Sought (EDS) pertaining to undersigned is clarified as under: -

As the forest clearance of the existing road has not been obtained in the past, the proposal for the diversion of total forest land area have been included as per the communication of Additional Principal Chief Conservator of Forests, Nodal Officer (FCA), letter no: PCCF/FCA/3240/4367-69. Dated: 30-01-2021. The letter reads "In case the forest clearance of the existing road has not been obtained earlier, then the proposal for the diversion of total forest land involved in the said road alignment under the Forest(Conservation) Act. 1980 may be submitted on PARIVESH portal".

Hence the forest clearance for the upgradation of existing road has been included in the proposal making total area of Forest land equal to 1.184 Ha. The calculations regarding the area of the forest land have been already uploaded on PARIVESH Portal.

3. Compensatory Afforestation proposal need to be corrected and be submitted as per details already communicated to all Divisional Forest Officers.
4. As the proposal has been processed for up gradation of existing road, it may be communicated whether the area of the existing road has been included in the proposal or not, reasons thereof.

The proposal is returned to your office for essential documents/ details in this regard be provided to proceed further in this matter.
