

SITE INSPECTION REPORT

(For the Forest land to be diverted under FCA)

Name of Project: - **Diversion of 3.01 Hectare Forest Land for Construction of 220 K/V D/C Ajmer-Bherunda for Excutive Engineer (T & C), RVPNL Ajmer.**

A proposal has been received by this office from **Excutive Engineer (T & C), RVPNL Ajmer** for diversion (under FCA-1980) of **Construction of 220 K/V D/C Ajmer-Bherunda for Excutive Engineer (T & C), RVPNL Ajmer on Forest Land to be diverted 3.01 hectare** of forest land for non forestry purpose. The subject envisages the use of forest land for **Construction of 220 K/V D/C Ajmer-Bherunda for Excutive Engineer (T & C), RVPNL Ajmer on Forest Land to be diverted 3.01 hectare** as described below as per submitted by user agency-

The site inspection of the land involved in the proposal has been done by me on dated **24.01.2018** On inspection of the site, it is found that the land required by the user agency is a forest measuring **3.01 hactare Forest land used Forest Block Hashiyawas Ardaka (PF).**
