POWERGRID Khetri Transmission System Ltd. (a 100% wholly subsidiary company of POWERGRID CORPORATION OF INDIA LIMITED) has been entrusted the work for evacuation of power from Solar Energy Zone in Rajasthan through construction work of 765 KV Double circuit line from Khetri(Rajasthan) to Jhatikra (Delhi).

For the subject work online Forest proposal no. FP/DL/TRANS/46658/2020 of Delhi state was submitted on dated 24.06.2020 for getting NOC. During examination of proposal by Nodal Officer of Forest department, Delhi following essential details was sought by Forest department:-

“It is to inform that the identification of land for Compensatory Afforestation is a pre-requisite in diversion cases. The proposal may be re-submitted with the details of CA land”.

Reply is as under:-

1. Land for Compensatory Afforestation for this proposal has been allotted by Delhi Development Authority (DDA) vide letter ref. no. F.LD/IL/0062/2020/GOVT/34-O/o DY. DIRECTOR (IL)/1308 dated 08.01.2021 and F.LD/IL/0062/2020/GOVT/34-O/o DY. DIRECTOR(IL)/1369 dated 20.01.2021. Copy of DDA letters are enclosed herewith.
2. Geo-reference Map of the CA land along with Survey of India Map topo sheet are enclosed for your ready reference.

Therefore, it is requested to you kindly review the case and forward to the concern DFO for further processing of Forest proposal.
