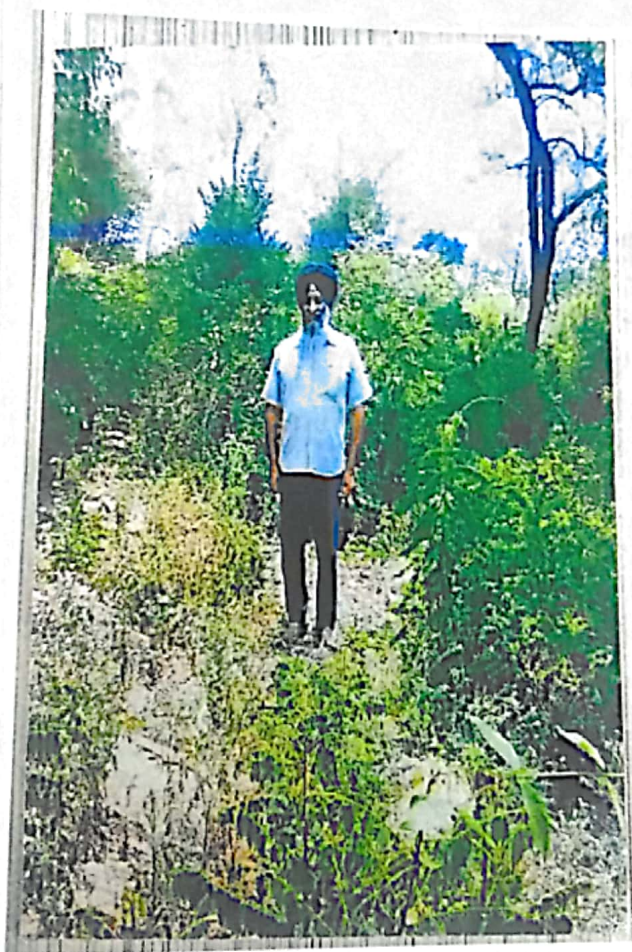

SITE INSPECTION REPORT OF CA SITE

- 1) Proposed CA site name :- Dhanera Forest
- 2) Polygon Area (In Hec.) : 1.00 Hec.
- 3) Proposed area for CA (in Ha.) : 0.538 Ha.

Proposed compensatory Afforestation site was inspected with concerned Field Staff and checked the suitability of proposed Compensatory Afforestation site of Dhanera Forest. Topography of the area is plain type. Lantana, Mallah, Kharkana etc. vegetation are found there. There are some trees/poles mainly Khair, Kikar, Shisham, and Other Misc. are standing on proposed polygon area of 1.00 Hec.

The polygon area of .KML File is 1.00 Hec. and proposed CA area for this case is 0.538 Hec. This proposed CA site area is suitable for plantation from management point of view. Brief Detail of proposed CA site is as under :-
