Hal/Sabik certificate of the concerned Tahasildar	The village wise detail land schedule and its abstract which was duly verified by the Tahasildar Kishorenagar as per the circular issued by Chief Secretary to Govt. of Odisha vide his letter no. R & DM-GE (GL)-S-63/13 4822/CS, dtd 12.02.2015. The details is being furnished as Annexure-III, Page No. 16 to 21.


04.	Land Schedule of both Forest & No-Forest land	The land Schedule of both forest and non-forest land is being furnished as Annexure-III, page No.- 16-21, in the Forest Diversion Proposal.
05.	Compensatory Afforestation	The Compensatory Afforestation map with KML file is enclosed as plate No. 5. The detail scheme and Land Suitability certificate is enclosed as Annexure-IX from Page No. 33-44 to the Forest Diversion Proposal.
