

This is in reference to your office letter cited above, it is intimated that the power evacuation of Jiwa-II SHEP (1.75 MW) is feasible at Raila Spur of 11kV Neuli feeder emanating from the existing 33/11kV, 2x3.15 MVA Sub-Station Sainj by making arrangement for the interconnection facilities near the JSV lift water scheme. The evacuation arrangement is subject to the following terms & conditions:-

- 1 IPP shall bear the cost of providing interconnection facilities and 11kV HT Line from the power house to said interconnection point. Necessary right of way (ROW) for the HT Line and land for the interconnection facilities shall also be arranged by the IPP.
- 2 Losses at 11kV from interconnection point to 33/11 kV S/Stn. Sainj shall be borne by the IPP
- 3 No deemed generation shall be allowed.

It is therefore requested that the consent of the above terms & conditions on the non-judicial stamp paper should be submitted to this office for further perusal of the case.






PLAN OF JIWA-II SHEP 1.75 MW







